Operational and Financial Update

On February 21, Chesapeake announced quarterly and full-year earnings for the period ending December 31, 2022:

Haynesville Operations:

- Currently operating seven drilling rigs in northwest Louisiana and expect to drop two rigs in the Haynesville during 2023, one in the first quarter and another in the third quarter
- Currently have two completions crews operating in the Haynesville and Bossier shales and expect to maintain this level of activity through year-end 2023
- Plan to increase gas gathering and treatment capacity by ~15% by 2H'23
- Entered into gas supply agreement with Golden Pass LNG facility
- Signed a long-term LNG supply agreement with Gunvor indexed to Japan Korea Marker

Current global events have placed energy production at the center of our national conversation. Chesapeake is proud of the role we play in powering Louisiana and America. IN THE COMMUNITY



ESG UPDATE

In 2022, Chesapeake achieved independent responsibly sourced gas certification across all of its natural gas assets under a combination of the MiQ methane standard, the EO100™ Standard for Responsible Energy Development and Project Canary's TrustWell certification process. Chesapeake is the first producer to achieve certification for produced and marketed gas volumes across two industry leading gas plays, delivering approximately 6 bcf per day of the premium commodity.



Strengthening Our Company Through Sustainability

In addition to independently certifying our natural gas production, Chesapeake is strengthening our company through sustainability by:

- Installed more than 2,000 methane monitoring devices across our assets and retrofitted more than 19,000 pneumatic devices
- Conducting aerial Gas Mapping LiDAR scans to detect emissions across all assets
- Reduced GHG and methane intensity by more than 50% since 2020

- Interim targets lowered to 3.0 GHG intensity and 0.02% methane intensity by 2025⁽¹⁾
- Targeting net zero GHG emissions by 2035
- Leverage existing expertise to adjacent CCS and geothermal projects with minimal upfront but impactful capital
- Allocate capital to meaningful emission abatement and potential revenue creating projects
